Purpose. Definitions.

- (1) *High-Performer PHA* A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on <u>both</u> of the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) **Small PHA** A PHA that is not designated as PHAS or SEMAP troubled, or at risk of being designated as troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceeds 550.
- (3) *Housing Choice Voucher (HCV) Only PHA* A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment, and does not own or manage public housing.
- (4) **Standard PHA** A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) *Troubled PHA* A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.

(6) *Qualified PHA* - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

Because of the success in adaption of these processes, DHA expanded remote servicing capabilities and incorporated them into our day to day operations to be ongoing with the ability for clients to request inperson interactions if they prefer, or if they have, or continue to have, issues with in-person servicing. By logging into their secure applicant, participant or landlord portals with usernames and passwords they create, clients can complete basically any process from applying for open waiting lists and updating contact information, household composition, income and preferences or checking wait list position; to completing annual or interim reexaminations and submitting required documents using a smart phone, requesting moving papers or having access to copies of documents like birth certificates and leases; to scheduling inspections, viewing ledgers of payments and disbursements, scheduling inspections and requesting
	moving papers.

PROJECT BASED VOUCHER ACTIVITIES -

NEW PROJECT. The DHA Board approved eighteen (18) PBVs for a senior project in 2018. That project is now online and pending applicant referrals from the DHA site-specific wait list for the property. Leasing is expected to begin in April 2021.

EXPIRING PBV CONTRACT. The DHA Board of Commissioners chose not to renew the PBV HAP Contract on a 91-unit senior property. The contract ends June 30, 2021 and the residents are being converted back to regular HCV's. At this time most have indicated they will remain at the property, so disruption is expected to be minimal.

HOUSING CONVERSION ACTION. DHA was made aware that a 321-unit property with sixty-four (64) units under a PBV HAP Contract is opting out as of July 31, 2021. That is a month into our new fiscal year on July 1, but reporting this now since most processing will be completed during the current fiscal year. At this time there has not been any additional follow-up from the property or the HUD Chicago Field Office on this project.

Goals under our objective to increase the availability of decent, safe and affordable housing:

All goals were met that we set for this category. Of particular note we added seventy-eight (78) Mainstream vouchers to our ACC and expect to add sixty-four (64) additional vouchers from a housing conversion action within our service area in July 2021. We again achieved SEMAP High Performer status for the 6th year in a row.

Goals under our objective to improve the quality of life and economic vitality; promote self-sufficiency and the use of asset development for individual households:

All goals were met that we set for this category. Of particular note is the expansion of remote access capabilities to essentially every service offered by DHA. Each client has their own username and password protected access through an online portal.

Goals under our objective to ensure equal opportunity in housing:

All goals were met that we set for this category. Of particular note is our work with the 125 agency DuPage Continuum of Care to help target underserved areas when opportunities arise for subsidized housing. This relationship was able to help seed the HCV waiting list for applicants with the Mainstream preferences for 18-61 with a disability.

Program expansion is greatly hampered by our current Repayment Agreement accessed against the agency through actions of a previous administration.
