# **MINUTES**

# DUPAGE HOUSING AUTHORITY BOARD OF COMMISSIONERS June 17, 2021

Pursuant to executive order 2020-07 signed by Governor Pritzker and guidance provided by legal counsel, DuPage Housing Authority conducted this meeting by use of electronic means using Zoom, without a physical guorum present in the boardroom.

In Attendance: DHA Commissioners, Dru Bergman, John Berley, Jessica Garmon, Stefanie Hood, Candace King and Chairperson Ingram.

Also present were Executive Director Kenneth Coles; Finance Manager Christine Celeste-Wade; Special Counsel Eric Hanson; and Sr. Administrative Assistant Susan Martin.

#### 1. CALL TO ORDER

The meeting was called to order by Chairperson Ingram at 8:46 a.m.

#### 2. ROLL CALL

A roll call showed that six Commissioners were present, a quorum.

#### 3. PUBLIC COMMENT

Beth Demes, Executive Director of Alden Corp., addressed the Board to request they open a Request for Proposals for Project Based Vouchers as they desire to build an affordable senior building in Addison.

### 4. APPROVAL OF MINUTES

Commissioner Garmon made a motion, seconded by Commissioner Hood, to approve the minutes of June 17, 2021. The motion carried unanimously.

### 5. FINANCIAL REPORT

Finance Chairman Bergman reported on developments including:

- The Finance Committee met on July 13, 2021.
- Cares Act funds have been applied to eligible expenses for fiscal year 2021.
- FY2021 "ended in the black".
- The annual audit has been scheduled.
- In maintaining proper systems and due diligence, the Committee recommends that DHA Management, Inc., being a separate entity from DHA, needs its own Finance Committee (same members as the DHA Finance Committee) and will hold monthly Finance Meetings immediately following the regular DHA Finance Meeting.

Director Coles explained the process for developers to receive Project Based Vouchers. Commissioner Berley, for record, is in favor of starting the process with a resolution to be on next month's agenda.
