Residents must meet the following criteria: 1.) A permanent documented disability due to a physical or mental condition or addiction; 2.) Documented homelessness of one current year or longer or four separate episodes within the past three years; 3.) The ability to live independently in the community without medical supervision; and 4.) Willingness to pay 30% of income towards rent. Fully furnished bedroom apartments are available.</p>	Olympus	50
<p>Property: <u>Trinity Alton Court</u>, Naperville, IL Unit Types: Group Living</p> <p>Description: Trinity Alton Court, run by Trinity Services, is a CILA (Community-Integrated Living Arrangement) and serves persons with developmental disabilities or mental health needs. Each home is staffed by independent living counselors who support the residents in maintaining the home and participating in community life.
