Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. Form HUD-50075-HP is to be completed annually by **High Performing PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, HCV-Only PHA, Small PHA, or Qualified PHA do not need to submit this form.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both of the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, or at risk of being designated as troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceeds 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment, and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

DuPage County has a continuous need for affordable housing for both individuals and families from every income level. The US Census Bureau lists more than 61,000 county residents have incomes below the poverty level resulting in escalating difficulty in finding housing as the household income declines. Families requiring larger units of three or more bedrooms are negatively impacted even more.</p> <p>b. Additionally, payment standards are changed effective 4/1/18 to be compliant with the Chicago Metropolitan Small Area Fair Market Rent area. All steps were completed to establish the SAFMR Payment Standards for the 49 zip codes & 6 different unit bedroom count categories.</p> <p>Strategy for Addressing Housing Needs: This has not been revised, however for general information:</p> <p>a. The Housing Choice Voucher general wait list will open for new applications on March 5, 2019 and 1,500 applicants will be added based on date and time of application. Approximately 400 applicants remain on the current list for processing.</p> <p>Deconcentration and Other Policies that Govern Eligibility, Selection, and Admissions. This has not been revised, however the Final Portability Rule and HOTMA will require a cover to cover review and ongoing revision of the current Administrative Plan. Additionally, DuPage County does not have any areas with high concentrations of poverty. Every census tract is considered an area of opportunity.</p> <p>Self Sufficiency Programs and Treatment of Income Changes Resulting from Welfare Program Requirements. This has not been revised, however:</p> <p>a. DHA continues to provide opportunities for HCV tenants to join the FSS Program. In growing the program by almost 25 new clients we currently have 105 participants but were not funded for the 2 coordinator positions. There are still plans to grow the program as we more closely collaborate with DuPage County in administering program participants, but the lack of funding is a barrier.</p> <p>b. DHA did revise our FSS Plan to include provisions for FUP Youth.</p> <p>c. DHA is not applicable to the Community Service/Welfare Program Requirements due to not having any public housing.</p> <p>Substantial Deviation. This has not been revised, however HOTMA required a cover to cover review and ongoing revision of the current Administrative Plan.</p> <p>Significant Amendment/Modification. In 2017 DHA initiated an RFP process and issued an RFP to determine interest of property owners who may want to do projects within DuPage County that have PBV's as a part of their subsidy layering financing. Nothing beyond the RFP relative to new PBV's is planned for this Fiscal Year. The selected owner is planning for a 68-unit elevator low rise for seniors in Naperville, IL with a 2020 or 2021 construction date. Total number of PBVs will be no more than 18 should they get an award.

In 2017 DuPage Housing Authority (DHA) initiated a PBV process that eventually resulted in the award of eighteen (18) project-based vouchers based on the RFP submitted by *Naperville Elderly Homes, Inc.* (NEH). Their project is a proposed new construction of 68 units of affordable rental housing for the elderly. NEH has owned and operated the age-restricted affordable rental complex known as the Martin Avenue Apartments continuously for over 40 years. The new project will be built on NEH controlled land in Naperville, IL immediately adjacent to NEH's existing 121-unit affordable rental complex.

Subsequent to the DHA award and as a part of their subsidy layering funding, NEH was awarded LIHTC from the *Illinois Housing Development Authority*, which included a dedicated percentage of units identified as *Statewide Referral Network* (SRN) units - targeted for households earning at or below thirty percent (30%) of the *Area Median Income* (AMI) with a head of household who has a disability or illness, including, but not limited to, a physical, developmental or mental limitation, substance abuse disorder, HIV/AIDS, or is homeless or at risk of homelessness. Acceptance of these SRN units require adherence to terms of the *Illinois Olmstead Coordinated Remedial Plan* and the use of the SRN referral list for applicants to vacancies as opposed to the requirements under 24 CFR 982.207(b)(3).

In 2013, HUD approved a request to allow PHAs in Illinois to voluntarily implement admission preferences for several classes of individuals, including SRN tenants (Olmstead), within housing programs receiving federal financial assistance from HUD. While this "blanket" approval was granted by HUD, DHA followed the defined steps in order to fully implement the new preference and permit the use of PBVs by SRN tenants (new preference). By Resolution, the DHA Board of Commissioners directed DHA's Executive Director to seek the proper waiver to establish a preference that will allow the use of its PBVs (in the case of NEH, 18 PBVs) by SRN tenants. On April 15, 2019, and to assist the State's efforts to comply with Title II of the Americans with Disabilities Act (ADA), Section 504 of the Rehabilitation Act of 1973 (Section 504), and the Supreme Court's decision in *Olmstead v. L.C.*, 527 U.S. 581 (1999), as well as with the terms of specific consent decrees resolving litigation within the State of Illinois, DHA as a participating State of Illinois PHA in the HUD-approved, "Illinois Olmstead Coordinated Remedial Plan", requested waiver from the US Department of Housing and Urban Development of [24 CFR 982.54] and [24 CFR 982.207(b)(3)], to voluntarily offer admission preferences for specific populations of persons with disabilities in the Public Housing, Housing Choice Voucher tenant-based voucher and Project-based Voucher (PBV) rental assistance programs, to further Olmstead implementation in the State. Essentially, this waiver allows DHA to utilize the Statewide Referral Network for certain vacancies within PBV projects. As indicated and required in *HUD Letter: Jeanine M. Worden, Associate General Counsel for Fair Housing, April 17, 2013*, DHA amended both this 2019 Annual Plan and the 2019 Administrative Plan to allow for this waiver and admission exception.

By initiating the PBV process we were in a position to assist a housing conversion action project at Mayslake Village in Oak Brook, IL that received Enhanced Vouchers in 2016, and whose tenants want to relinquish them and switch to PBV assistance under PIH 2013-27. The rents at the property are well below the payment standards for the HCV program so the EV households cannot take advantage of the 30% cap on tenant rent, so are paying much higher rents than they would pay because of the EV program rules relative to rents paid at the qualifying event.

B.3 Progress Report.

Provide a description of the PHA's progress in meeting its Mission and Goals described in the PHA 5-Year Plan.

The DuPage Housing Authority continues to work collaboratively with other social service agencies in the County to find ways to meet the needs of those who seek affordable housing. The QC & Compliance Manager of DHA continues to serve as the Chair of the Grants Funding Committee for the local Continuum of Care for the Homeless as well as serving on the Leadership Committee of this group.

The DuPage Housing Authority continues to partnership with the Regional Housing Initiative, which has again resulted in 90 mobility moves to opportunity areas for families.

The DuPage Housing Authority is expecting to award 18 PBV to a new project as they were successful in receiving IHDA tax credits.

Along with Hines VA, DHA made application for up to 25 HUD Veteran Affairs Supportive Housing (VASH) vouchers. On 2/22/18, DHA received notice from the HUD Financial Management Center we were approved to receive the maximum 25 of the F Y201 7 vouchers for the new PHS's. All VASH vouchers are utilized.

DHA continues to use a date and time format instead of a lottery system. This will require DHA to open the list more often for new applicants. As mentioned in above sections the HCV wait list is opening 3/5/19.

Next steps are pending a reply from the Chicago Field Office. Those findings were: <u>FINDING NO. 1: The DHA does not maintain proper internal controls over HCV funds.</u> DHA was required to execute a General Depository Agreement, properly listing all accounts that contain HCV funds on the Agreement. A copy had to be provided to QAD, the HUD Office of Housing Voucher Programs Financial Management Center (FMC), and the Chicago Field Office. Finding No. 1 was corrected. <u>FINDING NO. 2: The RNP and UNP account balances were incorrectly calculated and incorrectly reported in the VMS.</u> DHA was required to immediately make the appropriate adjusting entries to our general ledger and the Voucher Management System from December 2016 forward to ensure accurate RNP and UNP balances, cash/investment balances, and administrative expenses were reflected. When responding to Finding #2, Corrective Action No. 2 in the Corrective Action Plan (CAP), the DHA was required to provide detailed supporting documentation that appropriate adjusting entries had been made. Adjustments also had to be made where appropriate and necessary in the FDS submission(s) to the Financial Assessment Subsystem (FASS). Changes could not be made to audited submissions, but prior period adjustments and/or corrections to errors could be made in the current year prior to the final audited submission. Finding No. 2 was corrected. <u>FINDING NO. 3: The DHA has Insufficient Cash and Investments to Support the UNP Account Balance and Must Negotiate an Appropriate Repayment Agreement.</u> DHA must negotiate a repayment agreement with The Quality Assurance Division, in accordance with HUD protocol and processes due to mismanagement, misappropriation or theft of funds by a previous DHA administration. Point of contact is Yvonne C Stevens (yvonne.c.stevens@hud.gov). Finding No. 3 is pending response from the HUD Chicago Field Office. <u>FINDING NO. 4: The DHA has not Deposited Program Funds into Interest-Bearing Accounts as Required.</u> DHA was required to immediately transition program funds into interest bearing accounts and negotiate the required GDA as noted in Finding No. 1. Finding No. 4 was corrected.</p>
