The Housing Choice Voucher program offers two housing options: the *tenant*-based program and the *project*-based programs. The Project Based Voucher (PBV) program offers rental housing options at <u>specific</u> housing locations.

The DHA PBV locations in DuPage County offer a variety of housing options. Some buildings are intended for individuals or families; and others are age restricted for Seniors 62 years of age and older.

DHA opens its PBV Wait List as often as needed (only when funding is available) to provide assistance for low to moderate income individuals and families.

DHA is OPENING two of the DHA Project Based Voucher (PBV) Wait Lists on TUESDAY May 4, 2021 at 10:00 a.m. CST. Applicants will be able to apply for the wait list through an online application in their Rent Café account. The wait lists will CLOSE when the number of pre-applications have been COMPLETED and successfully SUBMITTED as indicated below.

Additionally, **DO NOT** provide personal information to anyone claiming he or she can guarantee a spot on the Wait List, improve your chances of selection for the PBV Wait List, or ensure that you will receive any DHA benefits!

WHEN THE WAIT LIST OPENS, you must successfully submit a pre-application online during the open period. The pre-application - which requires your name, date of birth, contact mailing address, email address, household income, number of household members and racial or ethnic designation of the head of household - must be submitted online using a computer, smartphone, tablet or other electronic device with Internet access. Applicants should have a valid e-mail address to apply. If you do not have Internet access, you may submit the pre-application online at locations throughout the County that offer free use of their computers, such as public libraries. Internet access is not available for submitting a pre-application at the DHA office.

To apply for the PBV housing options available, <u>you must be eligible to live at the property</u>, and <u>you must complete the online application for the specific property that meets your household needs!</u> You must apply to each PBV site you are eligible to apply for by checking that wait list during the application process.

REASONABLE ACCOMMODATION

Pre-applications will NOT be provided or accepted at the DHA Wheaton, IL location unless you have been *pre-approved* for a *Reasonable Accommodation* because of a disability or related condition that prevents you from equal access to the online pre-application process. Your accommodation request must be written and must describe the reason why the online pre-application process prevents you from accessing the pre-application. Pick-up Days for a paper copy of the pre-application for persons with an approved Reasonable Accommodation will be available ONLY through a SCHEDULED PICK-UP TIME between Monday, April 12th and Friday, April 23rd between 8:30 a.m. and 4:30 p.m. CST.

All pre-applications RECEIVED will be date and time stamped. If a paper copy of the pre-application is submitted **BEFORE** 10:00 A.M. CST it will be considered **REJECTED** due to the wait list not being open at the time of receipt of the pre-application!

PREPARING FOR WAIT LIST OPENING

IMPORTANT: When the DHA PBV wait list opens, the *Wait List Pre-application* will contain sensitive information about the applicant that is considered confidential. That information will be maintained in a *User Account* on our secure database. Access to the information in a user account will only be available to the applicant and DHA so **you must create a user account before you can submit an online Pre-application to apply for the DHA wait list. Unless permission for a Reasonable Accommodation has been granted, Pre-applications can only be completed and submitted online within your** *User Account***.**

If you answer Yes to **any** of the following questions, you already have a User Account and don't need to create another one:

- **1.** Are you a Participant *currently* on the Housing Choice Voucher Program in DuPage County under the DuPage Housing Authority?
- **2.** Are you a Participant *currently* on the Housing Choice Voucher Program in Kendall County under the Kendall Housing Authority?

- **4.** Were you a Participant on the Housing Choice Voucher Program in Kendall County under the Kendall Housing Authority but are no longer on the HCV program or no longer live in Kendall County?
- **5.** Were you on any Wait List for the DuPage Housing Authority that opened in *2016* or *2019*, or any Wait List for the Kendall Authority that opened in *2008* or *2018*?
- **6.** Are you a participant or former participant of the Illinois Rental Housing Support Program (RHSP) administered through DuPage Housing Authority or Kendall Housing Authority?

If you answered No to **all** the questions above, you Do Not have a RENT Cafe User Account and you **must** create one.

If you have a Rent Café account and forgot your password, you can select **Forgot Password** at the Login screen and it will walk you through resetting it. It is not required but it is highly recommended that before the DHA wait list opens for pre-applications at 10:00 a.m. Central, on Tuesday May 4, 2021, that you create your Rent Café account.

To do so:

- (1) visit the DuPage Housing Authority website at www.dupagehousing.org;
- (2) **select** the '**APPLICANT CAFÉ** link at the top right of page and you will be directed to the **Rent Cafe Login** page, then
- (3) select the 'Click here to register' link, then
- (4) follow the steps to create your account by entering your email address as a *username* and create a *password* that you choose. Please note that passwords must be a minimum of 10 characters, and must include at least one upper case letter, one lower case letter, one number and one symbol, such as a dollar (\$) or pound (#) sign.

Note: Once you create the user account, you will receive an email confirming your Rent Café user account was created. You are now ready to complete the pre-application once the DHA wait List opens for pre-applications.
