Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA’s operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA’s mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. The Form HUD-50075-HP is to be completed annually by **High Performing PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, HCV-Only PHA, Small PHA, or Qualified PHA do not need to submit this form.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment, and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

Unfortunately, IL101 DHA is under a 7 figure, multi-decade long repayment agreement as the result of actions of a previous administration in place at the authority prior to 2012. We are severely limited in our ability to expand program services beyond those for program participants and into the greater DuPage County service area.

Amounts owed back to HUD from mismanaged, misappropriated, or stolen program funds must be repaid from non-HUD, non-federal funding sources. Those funding sources are limited and inadequate to be able to continue to meet the payment requirements of the agreement. The current administrative reserves are being depleted because they are being

	<p>used to subsidize the annual payment requirement. Those reserves will run out within the next few years leaving the housing authority with insufficient non-HUD, non-federal funds and new funding sources to continue making annual payments per the agreement.</p> <p>Conversely, the HCV program and it's components are healthy and thriving. We continue to add new special purpose and targeted vouchers to our ACC total, including HUD V.A.S.H. vouchers, Emergency Housing vouchers, Mainstream vouchers and Enhanced vouchers from housing conversion actions within the service area.</p>

The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low-income families.
