FSS offers comprehensive case management and supportive services to assist families in reaching their self-sufficiency goals.



Our Mission

The overriding theme of Family Self-Sufficiency is to empower people to take control of their lives by becoming independent, productive members of their communities.

FSS does not simply attack the symptoms of poverty; it tackles dependency on all fronts and replaces powerlessness with empowerment and opportunity for a better future.

To become an FSS participant, all applicants must complete a structured application process which includes: educational workshops, an in-depth assessment, and development of an individual career and goal plan.
